HPLC analysis can yield inconsistent results for  $\Delta 8$ -THC and  $\Delta 9$ -THC due to isomer interference: GC MS/MS was employed to avoid this issue. Please note, if THCa is present, the  $\Delta 9$ -THC level measured by GC MS/MS might be higher due to decarboxylation.
